In terms of Section 4.10 of the MERJ Listing Requirements, the Cell would like to inform all affected persons that it will be in a closed period for the trading of its bonds from the close of market on 25 February 2022 until such time as the annual results for the period ended 31 December 2021 are published. The Cell anticipates that the results will be released by 30 April 2022.

During this period, all affected persons are prohibited from dealing in the Cells bonds, as it could be implied that they may be aware of unpublished price-sensitive information.
